Our background

- TEQSA is an independent statutory Commonwealth agency
- Established by the TEQSA Act in 2011
- Higher Education Standards
 Framework 2015, developed
 by the Higher Education
 Standards Panel (HESP)



Our objectives

- The TEQSA Act calls for us to protect and enhance Australia's:
 - international competitiveness in higher education
 - reputation for quality higher education and training services
 - excellence, diversity and innovation in higher education


TEQSA and **CRICOS**

- We are responsible for
 - -13,720 higher education CRICOS courses
 - Spread over 12 Broad Fields of Education
 - -Teaching 271,453 international students
 - with a further 98,782 students incoming (pipeline)
- We have processed 2490 applications for CRICOS registration, re-registration and other changes

CRICOS providers

141 CRICOS registered providers:

36 providers are currently under assessment (or have indicated interest in applying to become a higher education provider) who are also registered in accordance with the ESOS Act.



Higher education sector overview



As of August 2017:

166 registered higher education providers43 Universities

11 Non-university higher education providers with self accrediting authority

112 Non-university higher education providers



In 2015:

1.43 million students enrolled at Australian providers

Approx 50% of registered higher education providers also offer vocational education and training (dual-sector providers)



- 120,174 international higher education students are studying Management and Commerce courses
 - That's just over 44% of all international higher education students

International students in Australia


- 685,499 international students studying in Australia
- 27,1453 are enrolled in higher education
- 53% come from the following five countries:
 - 1. China
 - 2. India
 - 3. Nepal
 - 4. Vietnam
 - 5. Malaysia

The top six countries educate just over 50% of all internationally mobile students

Challenges of transnational education

Approx. 64,000 students pursuing Australian qualifications transnationally

Often studying through offshore campuses and partner institutions

This brings a need for:

- internationally robust frameworks for quality assurance
- the need for secure, international student mobility.



National Strategy for International Education 2025

- Goals include providing effective quality assurance and regulation by:
 - Maintaining strong quality assurance systems
 - Ensuring strong student protection

 - Supporting Australian cross border higher education and innovation
 - Building networks and collaborating to ensue quality

APEC quality assurance in online learning project


- Project undertaken on behalf of the Department of Education and Training for APEC economies
