Towards Automation

- The University of Adelaide's on-line application system launched in August 2011 in partnership with SATAC.
- Resulted in:
 - increased transparency and consistency of offer outcomes;
 - fast turnaround times: the majority of applications are dealt with centrally.



Transparency

- Transparent eligibility criteria are key to building a robust automated online system.
- Transparency is optimised by:
 - Simplicity of entry criteria (as distinct from "low entry criteria")
 - Standardised assessment practices.



Centralised International Admissions


- Organisational trust:
 - eligibility criteria and assessment practices must be *demonstrably* appropriate, effective, compliant

.....How?



- A template with detailed prescription of eligibility criteria for each award program, encoded for automated assessment.
- Academic details for CSM still 'owned' by each faculty via a process of continuous engagement.
- Enables transparency, equity and quality.

Assessment Quality

- Initial increase in application rejection rates.
- Continuous dialogue between Admissions staff, SATAC and Faculties resulted in refinement of the CSM's.
- Subsequent rejection rates have normalised and even lowered than that of the pre-SATAC environment.
- GPA's of international students have been maintained with a slight increase.



Advantages and Disadvantages

- Transparency in entry requirements.
- Consistency in decisions: the number of appeals based on purely academic grounds has reduced to zero.
- 21% more applications processed by 35% less staff since 2011.
- Major reduction in faculty referrals from 70% of all applications in 2011 to less than 30% at present.
- Not always suitable for quota-based courses in which ranking/merit plays a major role in admission.



A Public Version of the CSM

- The University's website entitled 'Degree Finder.'
- Planned functionality for online student appraisal before submitting an application.
- To be completed by December 2015.
- Credit Transfer System an important tool for self-appraisal of advanced standing.



From self-appraisal to self-assessment?

- CSMs contain <u>academic</u> eligibility criteria. Can this be extended to cover <u>all</u> aspects of admissions criteria?
- Will developments eventually enable an applicant to complete a full self-assessment online?



The Future

- From self-appraisal to full self-assessment?Perhaps not.
 - A complete self-assessment would represent an onerous task for applicants.
 - System design: complex integration with multiple systems.
- Increased transparency of entry requirements = increased risk of fraud.
- Digital and physical working together.
