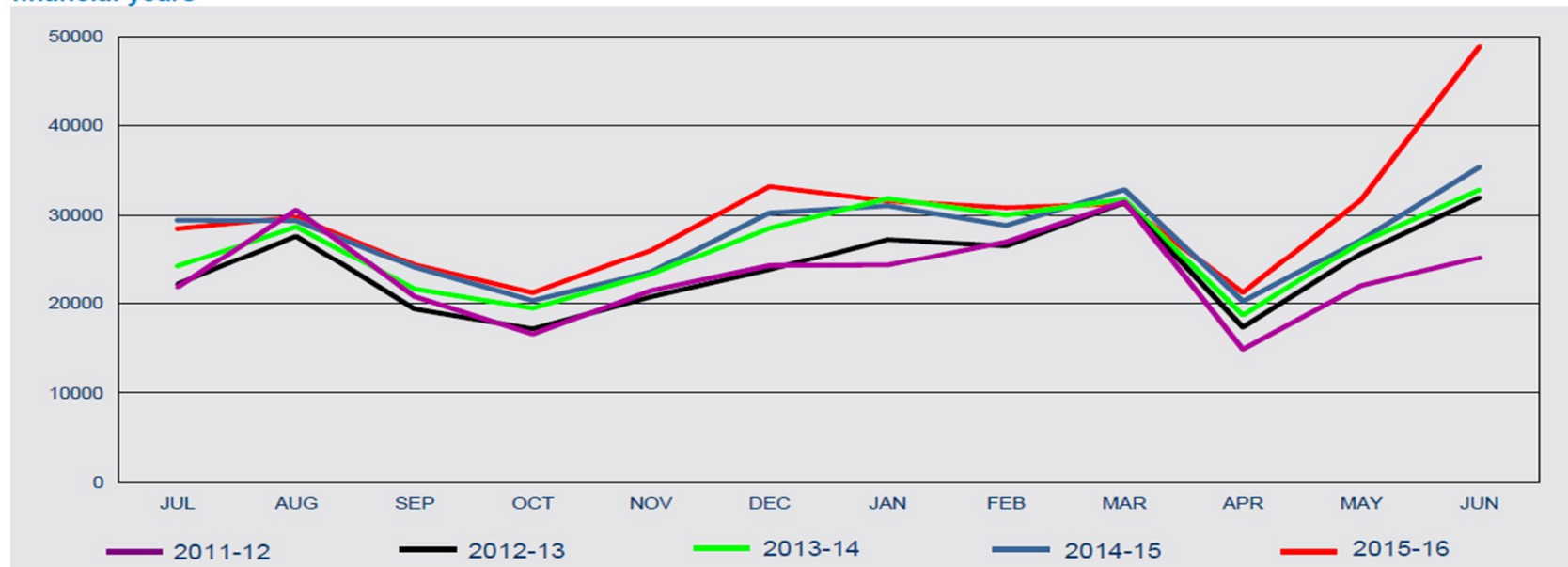

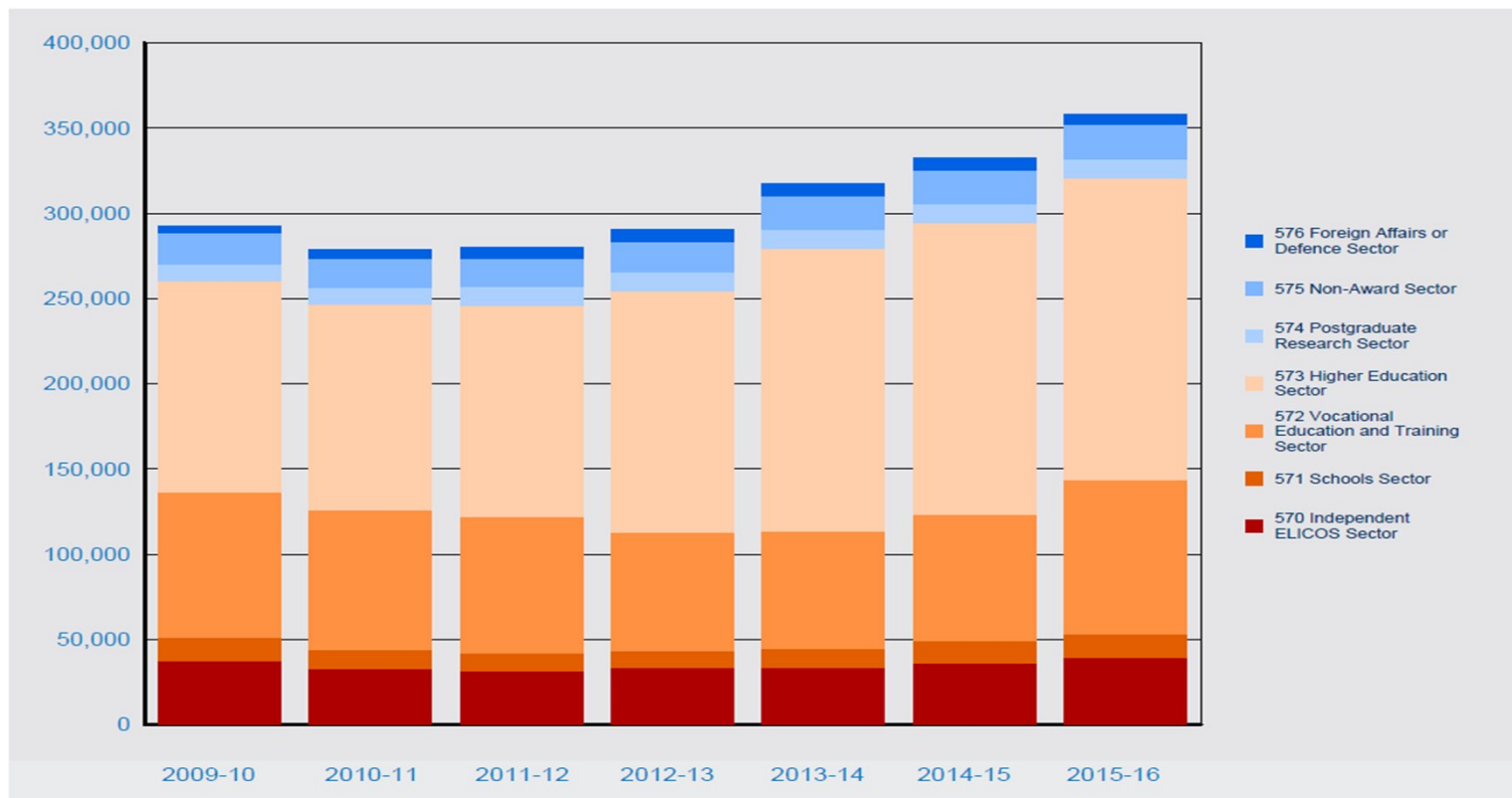

1.02 Number of student visa applications lodged in 2015-16 to 30 June 2016 by month - comparison with previous four financial years



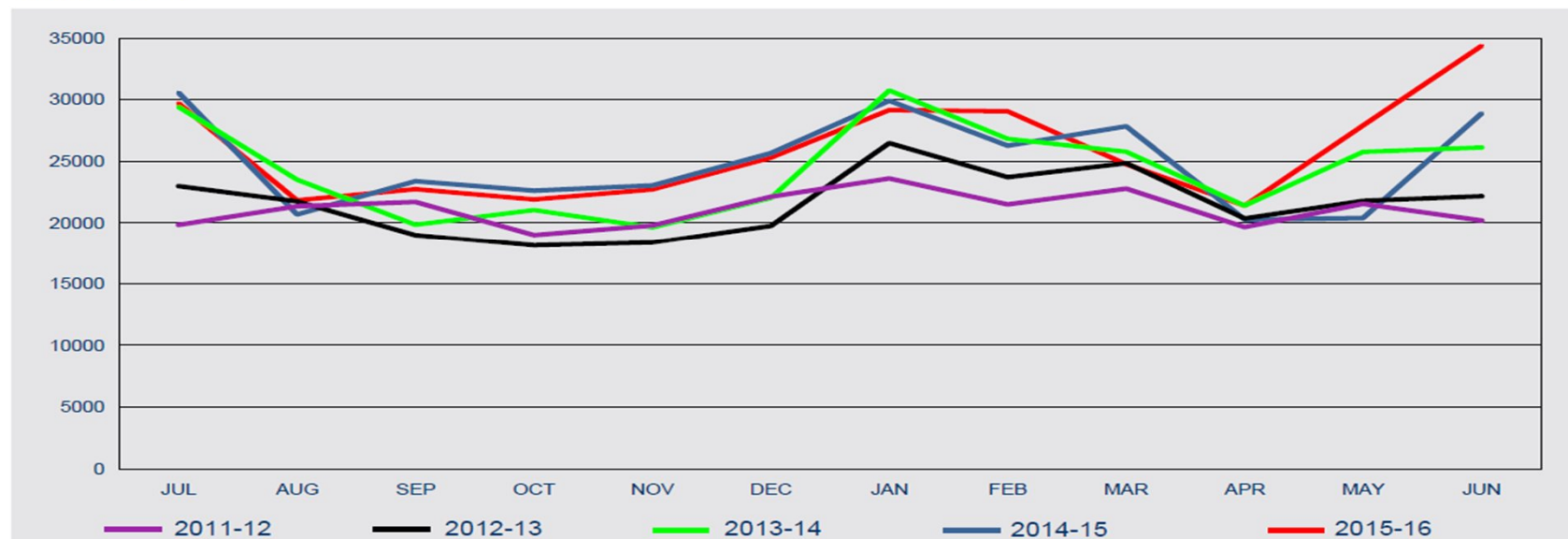
1.01 Number of student visa applications lodged by visa subclass in the last seven financial years

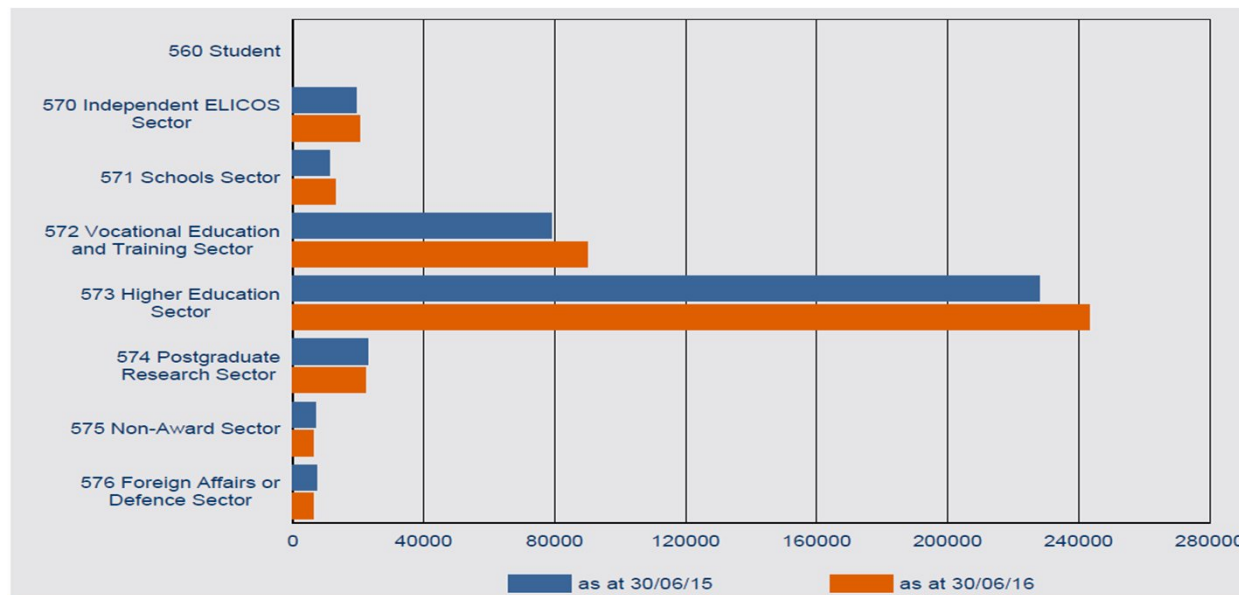

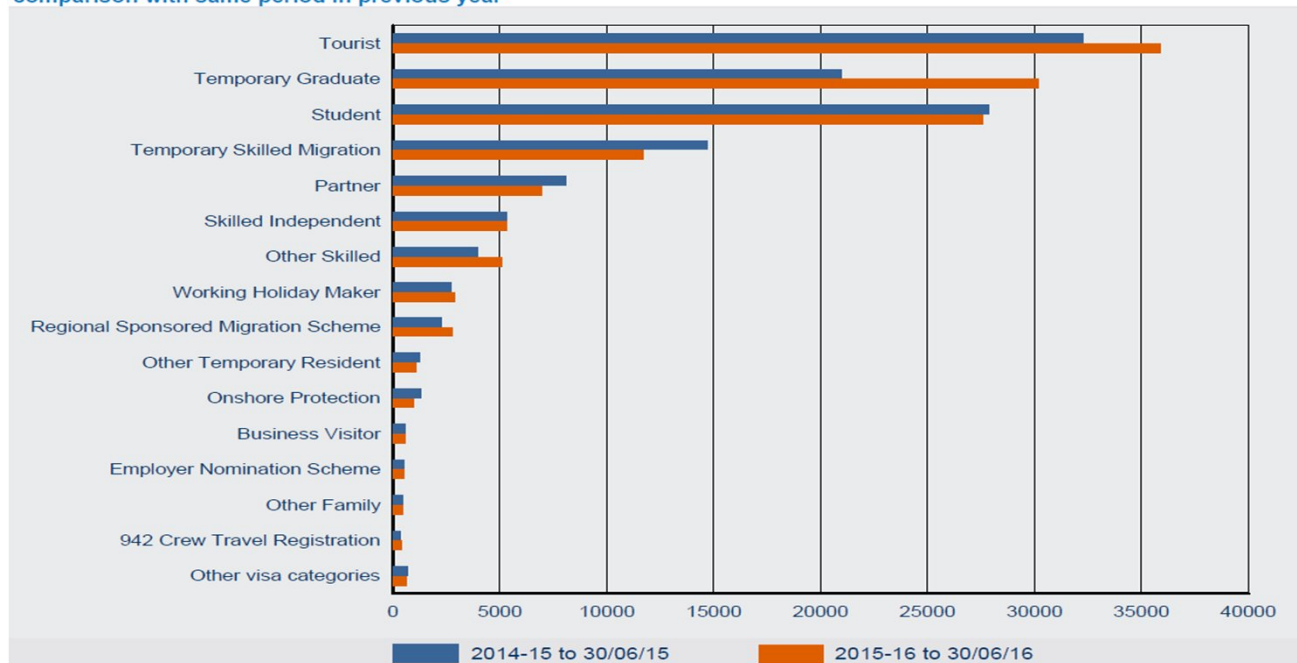

## More recent data

- Since 1 June 2016 – 30 September 2016:
  - 127,313 visas were lodged (up 8.0 per cent when compared to the same period last year).
  - 128,840 visas were finalised (up 12.0 per cent when compared to the same period last year).
  - 115,802 visas were granted (up 12.2 per cent when compared to the same period last year).
- The grant rate remains stable (91.1 per cent compared to 91.1 per cent compared to the same period in 2015).
